The Association for Commuter Transport will hold its Tenth Annual Conference at the Cavendish Conference Centre in London on Wednesday 7th February 2007. We are pleased to announce that the event is sponsored by BAA and Pfizer, two of our long-standing members.



Few can doubt that one of the major challenges we face over the next decade is addressing the challenges of climate change. The recently published Stern Report concluded that if we act now we could avoid the more extreme consequences that would result from inaction. To celebrate a decade of ACT we will be looking at 2020 Travel Planning and how it will impact on the future of transport.

Transport is responsible for over 20% of all UK emissions and is a sector where they continue to rise. Our Keynote speaker is David Quarmby CBE, a former board member of TfL and Managing Director of Sainsbury's, now with transport and planning consultancy Colin Buchanan. A leading thinker on climate change and transport, he promises an approach that will not be polemical, but objective, realistic and evidence based.

There is growing evidence that many of the major schemes to combat climate change are coming from the local level, rather than from central government initiatives. Our second keynote is an example of this. Cllr Serge Lourie is Leader of the Council at London Borough of Richmond; he recently stated in the press that to deal with climate change we can't afford to wait for central government or international consensus, but act now at the local level. He believes that we would save 15% of emissions if we all bought a smaller car. To achieve this he has proposed a parking levy of up to £350 for larger engine cars to park in Richmond, a policy which has afforded him a high level of notoriety in the press.

Additional speakers will address some of the key responses to the challenge that we as a sector can help implement, including the linkages between environmental management, corporate social responsibility and transport and concluding with a debate, where delegates will have the opportunity to register their opinions with a panel of experts.

The conference will also include insightful case studies, such as managing access for large shopping centres, often among the largest traffic generators but rarely effectively 'travel planned'.
